GLORY LTD. (the "Company") has announced the merger of the following consolidated subsidiaries of the Company, which was approved at a meeting of its board of directors on January 29, 2010: GLORY Kiki Co., Ltd, Harima GLORY Ltd. and GLORY TEC Ltd.

1. Purpose of the merger

The merger aims at enhancing cost competitiveness of the Company's products through upgraded production efficiency, which will be made possible through integration of manufacturing functions from parts processing to assembling, effective utilization of existing facilities and improvement of logistics.

The merger will be conducted in the form of absorption, in which GLORY Kiki Co., Ltd. will become the surviving company and Harima GLORY Ltd. and GLORY TEC Ltd. will be dissolved. Name of the surviving company will be changed to GLORY Products Ltd.

3) Merger ratio:

As the three companies are the Company's wholly-owned subsidiaries, there is no agreement on merger ratio.
