Newly-developed On-line Banknote Recycler, the RBG-300, for Retail Stores in Overseas Markets

GLORY has developed the RBG-300 banknote recycler to be released on September 14, 2011. The RBG-300 can be installed at back-offices of retail stores and connected on-line to a host computer of a financial institution to accept sales proceeds and dispense notes for change fund.

Main features:

- Works as both a sales proceeds acceptor and a dispenser change fund in retail stores.
- Enables direct depositing into and withdrawal from a bank account like an ATM by means of on-line connection to a host computer of a financial institution that monitors cash inventory in the machine.
- Accepts all denominations and dispenses up to five kinds of denominations at the rate of 10 notes per second while reading the serial numbers of all accepted and dispensed notes.

In the United States and Europe, many of retail stores depend on cash-in-transit companies (CIT) for handling of accepted sales proceeds and preparation for change fund. Sales proceeds that are collected from cash registers are once stored in a deposit machine, then picked up by a CIT and transported to a bank to be finally deposited into a bank account. Notes for change fund are also distributed by a CIT.

The newly-developed RBG-300 is a banknote recycler that is connected to a financial institution on-line, enabling depositing of sales proceeds directly into, as well as withdrawal of money for change fund from, a bank account. These functions contribute to more effective and stricter back-office operations in retail stores. Because cash inventory data in the machine is connected to a bank account, when sales proceeds are stored, the account will be updated. Additionally, as it is made possible to withdraw only necessary amount for change fund directly from the account, money can be managed in a more efficient way.

When notes are put in the entrance of the RBG-300, they are then counted and stored directly into the secured cassettes. The RBG-300 recognizes the serial numbers of notes during the deposit process. After the notes are stored, the amount will be credited to the retailer's account based on connectivity. The four built-in stacker cassettes can keep up to approx. 10,000 notes that can be recycled for use as change fund. Thanks to this feature, CITs can decrease the frequency of collection and replenishment, promoting efficient operation.

When cash in the RBG-300 is collected by a CIT, notes in the cassettes are sent to the lower collection drawer. Since the key for the cassettes is different from that for the collection drawer, a CIT operator can collect cash without intervention of an operator of the retail store.

The RBG-300 has auto verification feature to automatically recount notes in the cassettes on a periodic basis and compare the results with the database. When the cassette is opened/closed, the amount is automatically checked and cash can be strictly managed.

GLORY plans to introduce various products including coin/banknote recyclers for cashiers to support back-office operations in cooperation with financial institutions and CITs, thus expanding its share in the overseas financial and retail markets.
